

ARRAY BIOPHARMA INC. PRIVACY POLICY

Array BioPharma Inc. ("Array") respects the privacy of visitors to its website, and we recognize your need for appropriate protection and management of personally identifiable information you share with us. (We refer to any information that you provide to us through this website by which you can be identified, including your first and last name, email addresses, phone numbers or other contact information, as "*personally identifiable information*" in this policy.) This policy describes how we collect and use information about visitors to this website. By using this website, you acknowledge and consent to our practices described below.

Information We Collect. You may use our website without disclosing to us any personally identifiable information.

We collect personally identifiable information about you only if you choose to provide it to us. For example, we collect personally identifiable information you submit through this website when you contact us at the employment, business contact, or events calendar areas of our site. In all cases, we collect, store or use your personally identifiable information when it is voluntarily submitted to us. You may choose not to submit such information. If you choose not to provide certain information, you may be unable to receive certain services or information otherwise available to you.

Although our web server does log certain technical information automatically, such as the identity of your Internet Service Provider and your computer's IP address, none of this technical information reveals your identity to us, and it is not associated with any personally identifiable information you may choose to provide.

Any email messages and associated information that you send to addresses published on this website are not governed by this policy.

Use & Disclosure of Information. We track certain information about the use of our website, such as the total number of visitors to our site, the number of visitors to each page of our site, and the domain names of our visitors' Internet service providers. We analyze this website data for trends and statistics, but the individual user remains anonymous.

When you do provide personally identifiable information to us, we may use it in the following ways: We may use your personally identifiable information to respond to requests you may make of us, for example, to provide requested information to you about our company or our products. We also may use your personally identifiable information to communicate with you about a previous request or, where permitted

by law, to send you information you may find of interest. Also, we may use your personally identifiable information to better understand your needs and how we can improve our products and our business.

We may disclose your information, including personally identifiable information, to others performing services on our behalf. For example, we contract with a third party to maintain and host our website or to provide other services for which access to personally identifiable information is required. These companies may have access to your personally identifiable information as necessary to provide these services, but we contractually limit their ability to re-use or re-disclose it.

We may disclose your personally identifiable information in special cases when we have reason to believe that disclosing that information is necessary to protect our company or other website visitors or users (for example to identify, contact or bring legal action against a person who may be violating our Terms of Use or laws), or if we reasonably believe we are required by law to disclose it.

If Array should ever file for bankruptcy, undergo a reorganization, be acquired by or merge with another company, or divest a portion of its business, then we may transfer your personally identifiable information to the successor. Any and all uses of your information will comply with applicable laws.

Additional Information. Please be aware that the Array website is directed towards users who reside in the United States of America. It is not our intent to gather personally identifiable information from individuals residing outside the United States. If you are outside of the United States, by submitting personally identifiable information to us, you are consenting to the collection, storage and processing of that information in the United States and to any country to which we may transfer your information for the purposes described in this policy. If you are outside the United States, please note that the United States may have different laws concerning the privacy of personally identifiable information than your country of residence and may not provide the same level of data protection as the laws of your country.

MINORS. This website is not intended or designed to attract or collect any information from or about children under the age of 13. We do not collect information about the age of any visitors to our website. If you are a parent or guardian of a child under the age of 13 who you believe may have provided personally identifiable information to us, please contact us and we will promptly delete such information from our databases.

Changing Your Information. Any material changes to the policy will be published on this website. By your continued use of the website, you consent to the terms of the revised policy.
